美国食品药品监督管理局要求并推荐全球所有食品生产企业、医疗设备公司及制药公司将邓氏编码作为唯一的机构识别号码。

美国食品药品监督管理局使用邓氏编码作为唯一的机构标识符数据标准。该数据标准提供了一种高效的全球性一致手段来识别企业并获取其现有的完整信息，以此支持美国食品药品监督管理局与企业在全球范围内的正式业务往来。

申请邓氏编码

- 步骤 I: 确认该生产场地是否已拥有邓氏编码

邓白氏全球商业机构注册处拥有约 2.5 亿家企业的信息。虽然不能保证，但邓白氏很有可能已经保有您所提交企业的信息。请使用以下信息，通过电话或邮件的方式，联系华夏邓白氏寻求协助以确认该生产场地是否已拥有邓氏编码。请注意，此申请仅限于企业自身查询。

- 步骤 II: 申请为该生产场地创建邓氏编码

Obtaining a Dun & Bradstreet D-U-N-S® Number

A Guide for Food, Medical Device & Pharmaceutical Firms Located in China

The U.S. Food and Drug Administration (FDA) requires or recommends that all food manufacturing firms, medical device companies and pharmaceutical establishments located anywhere in the world utilize the Dun & Bradstreet Data Universal Numbering System (D&B D-U-N-S® Number) as a unique facility identification number.

FDA uses the D&B D-U-N-S® Number as a unique facility identifier data standard. This data standard provides an efficient and globally consistent means for the identification of a firm and access to current and complete information to support formal interactions between the FDA and companies around the world.

Request a D&B D-U-N-S® Number

- Step 1: Determine if a D&B D-U-N-S® Number already exists for your own manufacturing location(s)

The D&B global business establishment registry consists of information about some 250 million firms. It is likely, although not guaranteed, that D&B already maintains information about the firm or firms you represent. Please contact Huaxia D&B China (HDBC) by phone or email using the information below to request assistance in determining if a D&B D-U-N-S® Number exists for a specific manufacturing location. Please note this request is limited to inquiries on your own facility.

- Step 2: Request that a D&B D-U-N-S® Number be created for your own manufacturing location(s)
